Terms and Conditions

1. Instructions on how to enter and prizes form part of these conditions of entry. Participation in this promotion is deemed acceptance of these conditions of entry.
2. Entry is open to residents of Australia aged 18 and over only. Employees of Startup World, and their immediate families and agencies associated with this promotion are not eligible to enter.
3. Only one entry per person will be permitted.
4. The promotional period commenced on 18 June 2015 and closes at 11:59pm (AEST) on 31 July 2015. The judging will be conducted by a panel of judges appointed by the Promoter.
